

Home dog boarding form

- The hereby form has to be filled in by the dog's owner (or permanent caretaker) and handed in to the home boarding staff before proceeding with the booking procedure. A filled form is required in order to proceed with dog home boarding.
- The hereby form, even when handed over to the dog home boaring staff, is not yet a reservation and/or dog home boarding care agreement.
- A filled in dog home boaring form and the dog home boarding contract are a whole. The dog home boarding contract is signed beforehand or on the first day of the dog's boarding at the latest.
- The dog's owner/caretaker therefore confirms that all information provided in the hereby form is true to his/her best knowledge and that no essential information or information of intending value has been omitted.
- All white background fields have to be filled in. Fill in „does not apply” if a field does not concern the given dog.
